Program Summary


- MATCHING GRANT/ Reimbursement Program - 50 % match required
- \$50,000 Max. for Commercial/ Exterior Work
- \$25,000 Max. for Direct Residential Unit construction (Affordable for 90% of Median)
- \$100,000 Max. Per Property

What Can Funds Be Used For?

- Soft Costs Reimburse at completion
 - Must Bid Consultant Selection
 - Include at Project Set-up
 - Environmental Testing (Phase | ESA/Lead/Radon)
 - Design
 - Cost Estimation
- Capital Improvements
 - Exterior Façade/ Storefront
 - Interior Commercial
 - Direct Residential Build Out Affordable 90% Median

What Expenses Are NOT Covered?

- Site Work
- New Construction
- Structure Demolition
- Appliances, Furniture, and Fixtures
 Security System
 Sound System
- Parking Lots/Paving





Application Process

- Applications Due March 18, 2019
- Review by Advisory Committee
- Evaluation based on
 - Project Readiness
 - NYMS Program Priorities
 - \$25,000 for Small Projects (\$2 10K)
 - Leverage -50% Match or Better

Application Details

- Tenants May Apply
 - Need Owner Agreement
- <u>Rough</u> estimate for Scope of Work/ Costs
- Proof of Financial Ability to Complete Project
- Advisory Committee Wants to Maximize Grant
 Impact

Buffalo Place NYMS Priorities

- 10% Project Feasibility
- 18% Project Visibility
- 17% Project Impact
- 17%~ Renovation of Vacancy/ Upper Floors
- 10 % Development of Residential Units
- 15% Repairs and Code Compliance
- $\textbf{13\%}\$ Assistance Obtaining Grant from NYS

Project Initiation Requirements

- Project Initiation Fee of 1% Of Grant (Reimbursable At Conclusion)
- Develop Scope of Work Owner and BPI
- Buffalo Place Will Complete Environmental Checklist And SHPO Review

State Program Requirements

- Develop Written Scope of Work with BPI
- Scope Must Address:
 - Health and Safety Concerns
 - Code Violations
 - Lead Paint, Radon and Environmental Hazards
 - Energy Conservation
 - Preservation District Requirements -SHPO and Local

Project Initiation Requirements

Owner must provide Environmental Professional documentation

- A Record Search With Risk Assessment (RSRA)
- A Full Phase 1
- Updating an older Phase 1 to be current

Owner must sample suspected asbestos and/or lead based paint disturbed during project

Project Set-Up

- State Reviews Environmental Checklist
- State Sets-up Project
- Buffalo Place/ Owner Execute Agreement
- Owner May Now Solicit Bids
 Sent directly to Buffalo Place by Contractor!
- Wait for Buffalo Place Approval to Start Work!

State Program Requirements

• Contract Between Property and Buffalo Place

- Work To Start In 30 Days
- Insurance Hold Harmless Buffalo Place And State
- Inspections During And After Project
- Reimbursement Following Completion
- 5 Year Maintenance Period
 - Owner Must File Declaration With County Clerk (\$60)
 - Prorated Repayment To State If Demo Or Sold
- NYMS Photo Release

State Program Requirements

Contractor Selection

- Buffalo Place List

- In Progress Will Add Your Suggestions
- Obtain at Least Two Bids Deliver to BPI (!)
- State will Reimburse Low Bid Amount

State Program Requirements

- Grantees Must Comply with Equal Opportunity
 - Must solicit bids from Minority-Owned, Women-Owned and Service-Disabled Veteran Owned firms
 - Documentation of Bid Solicitation must be provided to Buffalo Place

State Program Requirements

• State Reimbursements Require:

- Written Bids (Delivered Directly to Buffalo Place)
- Written Contracts with Contractor
- Proof Contractors Have Been Paid
- Code Issues Resolved or C of O Obtained
- Buffalo Place Forwards Reimbursement Within Five Days After Receipt From State
